This petition seeks to refer HB 2569 to the ballot for a vote. HB 2569 stops elections officials from receiving private grants to help them run elections or register voters, even if the Legislature provides inadequate funding for elections administration and voter registration. Election officials have used grant funds to purchase equipment used to provide timely and accurate election results. If enough people sign this petition, the voters will decide whether election officials should be allowed to accept private grants.

2 Section 1. Title 16, chapter 4, article 1, Arizona Revised 3 Statutes, is amended by adding section 16-407.01, to read:

4 16-407.01. <u>Election administration</u>; private monies prohibited

5 NOTWITHSTANDING ANY OTHER LAW, THIS STATE AND A CITY, TOWN, COUNTY, 6 SCHOOL DISTRICT OR OTHER PUBLIC BODY THAT CONDUCTS OR ADMINISTERS 7 ELECTIONS MAY NOT RECEIVE OR EXPEND PRIVATE MONIES FOR PREPARING FOR, 8 ADMINISTERING OR CONDUCTING AN ELECTION, INCLUDING REGISTERING VOTERS.
